- I understand that I must submit a participation fee of \$40.00 per space needed (12X12) with this application to be considered for a space or to be designated an official site location. I understand that the participation fee is used by the 100 Mile Peanut Pickin' Yard Sale Committee to advertise and maintain the event. **I understand that the event will take place rain or shine, and that there will be no refunds.**
- I understand that the official locations will be open from 8:00 AM until 4:00 PM **2nd Saturday Annually in Oct.** I understand that **NO** clothing or other items bearing the official 100 Mile Peanut Pickin' Yard Sale logo are to be produced or sold at this event. Setup sites and locations are limited and will be on a first-come, first-serve basis. **Please try and keep your booth open until 4:00 PM. Buyers will be traveling a great distance to shop and may not arrive in your area until later in the time frame.**

Space assignments will be made closer to the actual event date. Applications may be mailed to the City of Quitman, P O Box 531, Quitman, GA 31643. If there are spaces available the day before the sale, they will be made available and designated on a first-come, first-serve basis once application and fees are received. The Main Event site will have a coordinator who will be your contact before and after the sale.

We encourage antiques, jewelry, crafts, furniture, farm equipment; nearly everything! You are allowed to sell prepackaged food items, drinks, baked goods and boiled peanuts.

Please ensure that you submit a valid, working email address if you require confirmation of receipt of money and space.

If you are going to be located out in the county, we suggest that you utilize areas that will be hosting cluster sales as these will be planned on the route, and will be listed in advertising. These cluster sales will encourage more people to stop and browse your wares.

Sale begins promptly at 8:00 AM the day of the event. **Please try and keep your booth open until 4:00 p.m. Buyers will be traveling a great distance to shop and may not arrive in your area until later in the time frame.***
